MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Investment Objectives and Strategies

The investment objective of the Educators Monitored Aggressive Portfolio (the "Fund") is to provide a balance of income and potential for long-term capital growth. It does this by maintaining a balance of investments across several asset classes. The Fund invests primarily in mutual funds that invest in securities of Canadian and foreign governments and corporations. The asset mix is varied depending on the outlook for the economy and financial markets. The fundamental investment objective of the Fund may not be changed without the prior approval of the unitholders.

Risk

The risks of investing in the Fund remain as discussed in the Simplified Prospectus. Since inception of the Fund no changes affecting the overall level of risk of investing in the Fund were made to the Fund as at December 31, 2020.

The impact of the coronavirus (*COVID-19*) pandemic on the financial performance of the Fund's investments will depend on future developments, including the duration and spread of the outbreak and related advisories and restrictions. This public health crisis and the impact of *COVID-19* on the financial markets and the overall economy are highly uncertain and cannot be predicted. If the financial markets and/or the overall economy are impacted for an extended period, the Fund's future investment results may be materially affected.

Results of Operations

The Fund's net assets increased by 19.5% to \$49.1 million at the end of December 2020, up from \$41.1 million at the end of December 2019.

Investment Performance

For the year/period ending December 31, 2020 (the 'period'), the Educators Monitored Balanced Portfolio – Class A Series provided a return of 3.93% versus a Benchmark return of 8.58%. The Benchmark is a weighted composite consisting of 12.5% MSCI EAFE Index C\$, 15.0% S&P 500 Index C\$, 24.5% S&P/TSX Composite Index, 37.0% FTSE Canada Universe Bond Index, 6.0% FTSE Canada Short Term Bond Index, and 5.0% FTSE 91-Day T-Bill Index (the 'Benchmark').

The Fund underperformed its blended Benchmark over the period. Unlike the Benchmark, the Fund's return is net of fees and expenses paid by the Fund. Please refer to the "Annual Compound Returns" in the Past Performance section for the returns of all classes of the Fund. Detailed performance is provided under the heading "Past

Performance" in this report. Investors cannot invest in the Benchmark without incurring fees, expenses and commissions which are not reflected in index returns.

Class E units of the Fund were launched on February 4, 2020. Due to policies issued by the Canadian Securities Administrators, investment performance data is not reported for funds in existence for less than one year.

2020 may have been one of the most challenging periods for many, yet it was encouraging to end the year with a ray of hope. *COVID-19* vaccination programs had begun, which may help to restore a sense of stability gradually throughout 2021 and allow for further widespread economic re-opening. From a capital market performance perspective, 2020 also stands out for its incredible comeback from March's pandemic-fueled downturn, helped by unprecedented policy support and investors' hope for a continuing recovery back to pre-virus levels in the coming years.

For the full year, in Canadian dollar terms, U.S. and emerging market equities returned more than 16%. While Canadian and international equities rose by 5.6% and 5.9%, respectively. Elsewhere, helped by lingering investor worries and easy (*money*) policy, the Canadian bond market gained 8.7%. Within the commodities markets, oil dropped 20% and gold finished the year up 23%.

Security selection headwinds in the foreign, U.S., and Canadian equity segments were the main negative contributors. From an asset allocation perspective, a lower allocation to Canadian bonds (*relative to the Benchmark*), combined with allocations to emerging market debt and global high yield bonds, also detracted value. However, all bond segments outperformed their individual respective market indices. Within equities, allocations to emerging markets and Canadian small cap stocks contributed to relative performance.

Recent Developments

The global recovery has entered a phase the portfolio manager is calling the 'restoration economy' and it dominates their investment outlook as we move into 2021. The scenario is one where economic growth moderates after the extraordinary rebound experienced over the past nine months. It also refers to the portfolio manager's market return expectations, which are still positive, albeit somewhat moderated because of the intensity of the rally they have observed. Additionally, the portfolio manager believes that the overall economic fallout from the

pandemic is likely to dissipate as aggressive policy continues to support economic momentum.

With these expectations, the portfolio manager is modestly *pro-risk* in the portfolio, with a tilt towards stocks over fixed-income and cash. Comparing against their normal strategic allocations within fixed income, the portfolio is roughly neutral weight in Canadian bonds and global high yield bonds, while keeping an overweight position in shorter-term mortgages until the cash can be redeployed as other opportunities arise. The portfolio manager also holds underweights relative to their long-term strategic allocations in global inflation-linked bonds and emerging market debt. Within equities, the portfolio manager has maintained a preference in North American equities, while still ensuring the portfolio remains well diversified across asset classes and geographies.

An unexpected deterioration in pandemic developments (*i.e. vaccination delays and/or viral variants*), changes in fiscal or monetary policy direction, and the relationship between China and the U.S. are all key risks that the portfolio manager continues to monitor/remain mindful of.

Pursuant to the Fund’s investment strategies included in the Fund’s Simplified Prospectus, the Fund may invest in other mutual funds and for the period has invested in HSBC International Equity Pooled Fund; HSBC Mortgage Fund, Institution Series; HSBC Emerging Markets Debt Fund, Institutional Series; HSBC Global High Yield Bond Pooled Fund; HSBC Emerging Markets Pooled Fund; HSBC Global Inflation Linked Bond Pooled Fund; and HSBC Small Cap Growth Fund, Institutional Series which are funds managed by the Fund’s Portfolio Manager.

In 2020 Educators Financial Group did not refer any conflict of interest matters to the Fund’s Independent Review Committee (IRC) and accordingly did not rely upon any recommendation of the IRC in respect of any related party transactions.

Educators Financial Group is the Manager and Trustee of the Fund. Educators Financial Group is a wholly-owned subsidiary of the Ontario Secondary School Teachers’ Federation (“OSSTF”). OSSTF may from time to time invest in units of the Fund.

⁽⁶⁾ The management expense ratio before waivers or absorptions shows what the management expense ratio of the Fund would have been if Educators Financial Group had not charged a lesser amount for its management fee.

⁽⁷⁾ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period.

⁽⁸⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio manager manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a fund's portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.



Management Fees

Educators Financial Group is the Manager-Trustee, promoter, and principal distributor of the Fund, and is responsible for the day-to-day management and administration of the Fund.

The Manager-Trustee monitors and evaluates the performance of the Fund and pays for the investment management services of the portfolio manager, as well as all administrative services required by the Fund. As compensation for these services, Educators Financial Group is entitled to receive a fee, payable monthly and calculated daily, based on the Net Asset Value of the Fund, at the annual rate of 1.65% for the Class A Series and 1.32% for the Class E Series. The Class I Series is identical in all aspects to the Class A Series, except that there is no management fee payable by the Fund in respect of the Class I units.

The Fund is responsible for paying any applicable tax owing on its management fee.

Approximately 13.3% of the total management fees collected from all Series were used to pay for portfolio management services, with the remainder of the fees being allocated to custodial services, marketing, technology, and Manager-Trustee operating expenses.

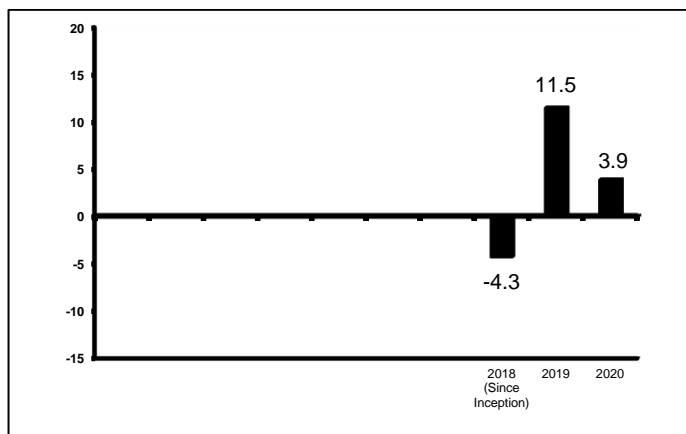

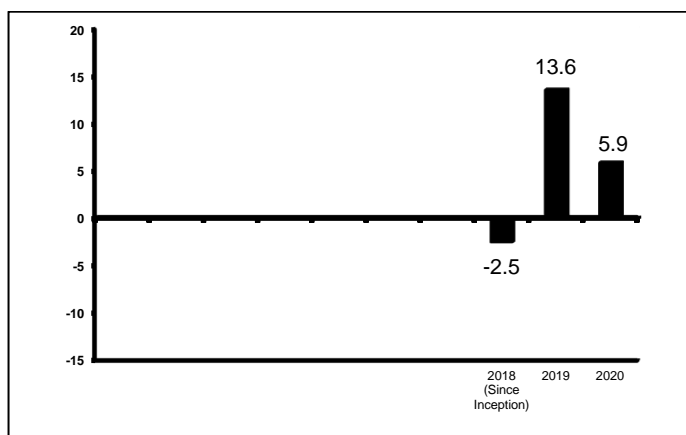
Year-by-Year Returns

Annual Compound Returns

The following table compares the historical annual compound returns of the Fund with the performance of the blended Benchmark index comprised as follows: 12.5% MSCI EAFE Index C\$, a stock market index that is designed to measure the equity market performance of developed markets outside of the U.S. & Canada, 15.0% S&P 500 Index C\$, a stock market index based on the market capitalizations of 500 large companies having common stock listed on the New York Stock Exchange, 24.5% S&P/TSX Composite Index, a capitalization-weighted index designed to measure the market activity of some of the largest float adjusted stocks listed on the Toronto Stock Exchange, 37.0% FTSE Canada Universe Bond Index, which is a broad measure of the total return of Canadian bonds that mature in more than one year 6.0% FTSE Canada Short Term Bond Index, a market capitalization-weighted index consisting of a broadly diversified range of investment grade federal, provincial, municipal and corporate bonds with a term to maturity between one and five years and 5% FTSE Canada 91 Day T-Bill Index, which measures the performance attributable to 91-day Treasury Bills of the provincial and federal governments.
